RESOLUTION AND ORDER NO. 8212020

A RESOLUTION AND ORDER OF THE BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 7 SETTING THE TAX RATE FOR THE 2020 TAX YEAR.

WHEREAS, the Board of Commissioners (the "Board") of Bexar County Emergency Services District No. 7 (the "District") voted, by a count of four (4) in favor and none opposed, to propose a tax rate of 0.096503 per \$100 valuation (the "Proposed Tax Rate"); *and*

WHEREAS, the Proposed Tax Rate is equal to the de minimis rate; *and*

WHEREAS, the Proposed Tax Rate is not greater than the no-new-revenue tax rate; *and*

WHEREAS, notice of a public hearing on the proposed tax rate was published in the Helotes Echo; *and*

WHEREAS, after holding a public hearing on the proposed tax rate and allowing all interested citizens to comment, the Board voted to adopt the Proposed Tax Rate.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF COMMISSIONERS OF BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO.7 THAT:

Section 1. The tax rate for the 2020 tax year for the District shall be set at 0.096503 per \$100 valuation, which is equal to the de minimis rate and is not greater than the no-new-revenue tax rate.

Section 2. At its duly called and legally conducted meeting held on the 21st day of August, 2020, following a public hearing on the matter, the Board voted to adopt the above tax rate for the 2020 tax year as follows:




